#### 1 - Not Sustained - Operation/Personnel Violations/Neglect of Duty

**Allegation:** It alleged by the Complainant Commander Warren Richards that the accused Lt. Allison Schloss committed a rule 14 violation when she responded to an OLA (Office of Legal Affairs) Request Report on 25 February 2018.

#### 2 - Not Sustained - Supervisory Responsibilities/Properly Monitor/Inspect Subordinate

**Allegation:** It is alleged by the Complainant Commander Warren Richards that the accused Lt. Allison Schloss failed to properly manage a Hit and Run Investigation while she was assigned to the MAIU (Major Accidents Investigation Unit) during the time frame of February 2018 through February 2019. These incidents were recorded under RD# HZ-558578 and HZ558638.
