INCIDENT DESCRIPTION

The R/P alleges the accused failed to allow her the chance to file a theft report. The R/P is a possible witness to a homicide that occurred in the spring/summer of 2016 near 75th & Coles. As the R/P was sitting in her vehicle, two men who presented themselves as officers approached her and called her by name and stated, I want to talk to you. The R/P stated she responded by saying I don't wanna talk to you States Attorney. The two men never presented any identification to the R/P; however, the R/P believes that the two men were from the States Attorney's office because one of the men was wearing a lanyard that read States Attorney. They were dressed in plain clothing, and one was wearing what appeared to be a bulletproof vest that read Police. The R/P believes that his name is possibly Donovan. The other man the R/P had no name for. They were driving a Navy impala, license plate MP 8477. When the R/P refused to speak to the two men, Donovan walked behind the R/P's vehicle and began to remove the registration sticker from the R/P's license plate. As she prepared to drive away, Donovan asked her if she was going to drive a vehicle with an expired license plate.

As a result of what occurred, the R/P called for police assistance. Two CPD uniformed officers responded. The R/P explained the incident to them, further stating that she did not know if the men were police officers. The accused stated that they spoke with the two men and confirmed that they are police officers. The R/P asked if that gave them the right to take stickers from her car, to which the accused stated no. The R/P began to walk away when the accused not named Rogers/Rodgers asked her what she would like them to do since they were there to help her. The R/P stated that she would like to obtain a report for theft. When asked by one of the accused what the R/P would like the report to say, the R/P stated that she would like to report a theft. At that time, the accused with the last name of Rogers or Rodgers stated I'm not dealing with this shit and walked away. The R/P stated that she said God bless you and some other statements that she could not recall, then left.
