INCIDENT DESCRIPTION

I had several encounters with peace officers at 16th District whenever I filed police reports, ranging from identity theft to motor vehicle theft. 16th District peace officers wrote misleading reports and unsubstantiated information after reporting an incident. For instance, I reported to a peace officer about motor vehicle theft in March 2015 and the entire report was completely misleading and more or less falsified after I requested the original case incident report from the Chicago Police Department Headquarters at 35█ S Michigan Ave, Chicago, IL 60653. When I read the full report, that includes the detectives investigative report, the report of the investigation was misleading and unsubstantiated. When I reported for identity theft, your peace officers ignored me and decided to write a narrative which was different and not parallel to the incident that I have reported. In addition, one of your peace officers removed his name tag or pin when I reported an incident.
