INCIDENT DESCRIPTION

After calling ohare airport police to report a solicitor officer Bernal arrived. From his vehicle he clearly gave me the middle finger. As I approached him to ask why he was flicking me off he got out of the car and said he was getting sick and tired of my bullshit. He then told me that I needed to stop calling to report this bullshit. I stated to officer Bernal that every time I see a solicitor I would call to report them. He then stated that he would start writing me tickets then. I asked for what and he responded for soliciting and trespassing. He then asked me for my ID which I provided to him. He stated that my State ID wasnt good enough and that he wanted a airport badge. I stated that I was not required to have one. He stated if I could not provide the ID he wanted he would write me tickets. He stated just because I was wearing a limousine company shirt it didnt mean shit. I told the officer that if he was going to write me tickets to go ahead and do it. At that point he handed me my ID back and allowed me to return to the inside of the terminal where I was meeting 26 passengers from a Emirates flight from Dubai. I was working with two female coworkers as well as another male coworker.

About 510 minutes later officer Bernal approached with a second officer where I was waiting for my passengers. They told me that I needed to come outside with them and told me to grab my things. Once outside I was directed to a an area where Bernal told me that he had talked to my companies dispatcher and he was told that there were only two women working for them inside the terminal. Upon talking to my boss who was working in dispatch at the time he told me that no one had taken a call from the police and the fact there was another male employee working with us at the time shows that he was lying. He stated I had no business there and was causing trouble. I offered to show him my work order listing all of the passengers on the Emirates flight as well as another order that was for a single passenger. They refused to look at my paperwork and stated that anyone could print something and bring it there. I was then asked for my ID again. I provided it to Bernal. He then walked to the vestibule nearby and actually called my dispatch department who informed him that I was in fact there on company business. He came back, handed me my ID and commented on how Ive now been identified as the one who is harassing the solicitors. I stated I did not believe the way he was acting was professional especially when he gave me the middle finger. Bernal said is that what I did Could you see that clearly inside my vehicle I responded that I could see it clear as day and his response was no, I think I was just pointing at you. Why would he have been pointing at me

I had a previous interaction with Bernal where I reported two solicitors who were directly outside of the terminal doors. His response at that time was how does it affect you I stated that they were breaking the law. He responded something along the lines of no one is being injured or bleeding. I told Bernal that I felt the people who get in the cars with the hustlerssolicitors were being put at risk if they didnt pay whatever was demanded of them. He commented again along the lines of I just dont understand why you involve yourself with them.
