INCIDENT DESCRIPTION

During a scheduled Bureau of Internal Affairs Integrity Check on 16 MAY 2019, in preparation for a long gun destruction, the listed accused members were inattentive to duty in that the accused Police Officer BRYANT #17393, incorrectly listed a Winchester , Model 250, serial # [REDACTED], 22 Caliber, 19 Inch blue steel rifle on inventory sheet #14185525 when it should have been listed on Inventory sheet #14185520 and listed Winchester, Model 1400 Serial # [REDACTED] 12 Gauge, 28 Inch blue steel shotgun on Inventory Sheet #14185520, when it should have been listed on Inventory Sheet #14185525. The accused, Sergeant VASSELLI #2213 and Sergeant SANCHEZ #2327 approved the respective inventories.
