INCIDENT DESCRIPTION

On 21 MAY 2019, during an Integrity Check for short guns (handguns) scheduled to be destroyed on 22 MAY 2019, it was discovered that the listed accused, Police Officer Jenelyn FIGUEROA, Star #15428, listed a 44 Caliber, Colt, blue steel revolver with 6 Inch barrel Model No. 3, serial #979 under Inventory #2451892 as being in Box # GS306. An intensive search of said box concluded that listed firearm was missing. At the time of this report the whereabouts of the firearm could not be ascertained.

Allegations

1 - Sustained - Operation/Personnel Violations/Neglect of Duty

Allegation: It is alleged by Sergeant Michael Fitzgerald #1738, the accused, Police Officer Jenelyn FIGUEROA, star 15428, on 21 May 2019 improperly scheduled the firearm inventoried under Inventory Number 2451892, which was no longer in the custody of the Chicago Police Department, for destruction.

Rule Violation: Rule 10: Inattention to Duty - On 21 May 2019, during an Integrity Check conducted at the Evidence and Recovered Property Section, the firearm inventoried under Inventory No. 2451892 was listed on the Destruction Record for the box marked GS 306. An inspection of the contents of this box revealed the weapon was missing. Officer FIGUEROA was identified as being responsible for conducting the research into each firearm listed on the Destruction Order, locating those weapons, removing them from their stored location in the gun vault, and ensuring they were placed into the box labeled GS 306. Through investigation it was determined the missing firearm had not been in the care and custody of the Chicago Police Department since July of 2001. Officer FIGUEROA failure to discover this information and inability to locate the firearm resulted in it being improperly included on the Destruction Record .

1 - Exonerated - Operation/Personnel Violations/Neglect of Duty

Allegation:

It is alleged by Sergeant Michael Fitzgerald, star 1738, the accused, Evidence Technician Marina JURASSI, star 13542 converted Inventory Number 2451892 into the CLEAR System on 05 December 2015 and improperly placed holds on property which was not in the possession of the Chicago Police Department on that date. These discoveries were made after an Integrity Check on 21 May 2019 at the Evidence and Recovered Property Section revealed the firearm inventoried under Inventory Number 2451892 to be missing from that location.
