#### INCIDENT DESCRIPTION

The Reporting Party Victim (RPV) alleges that the accused failed to provide police service in that the accused did not respond to the 911 call she placed. The RPV stated that she told the 911 operator that she was on the fourth floor of the parking garage and that she was a Judge trying to get to court at the Daley Center. The RPV alleges that while parked in the parking garage an unknown individual kept staring at her vehicle and then started to walk towards her vehicle while holding his waistband and eventually blocking the RPV's car door. The RPV alleges that this unknown individual then became belligerent and would not walk away from the RPV's car and per the RPV stated to the RPV and passenger "I will kill both of you all." The RPV stated that when she brought this incident to the attention of the Interpark staff, the RPV was told that the police had contacted the Interpark office, but no attempt was made by CPD to contact the RPV. The RPV states this incident lasted at least ten minutes.
