INCIDENT DESCRIPTION

I was a victim of a battery inside a bar, and was the first one who called 911 to request assistance, two police cars came and handcuffed me right away, instead of listening to my story, they took sides and were aware I was assaulted but they refuse to take my statement.

When I got put into the police car my rights were not read to me during the whole time.

I came back to station on Logan Square after I was discharged to file a police report at 6am, a supervisor with white uniform yelled at me with profanities in front of everybody, bullying me and insulting me telling me we will not file a police report for you.

The police officer committed the following racial discrimination

refusal to file a police report,

arrested me based on other parties statement, were aware of my assaulter been inside the bar but refuse to investigate.

I was bullied at the premise.

10 JUNE 2019,

RI [REDACTED] CALLED THE RS TO REVIEW HIS ALLEGATIONS AND COMPLAINT. THE RS STATED THE ACCUSED REFUSED TO PROPERLY INVESTIGATE THE INCIDENT AND WOULD NOT ALLOW HIM TO SIGN COMPLAINTS AGAINST THE CIVILIAN WHO ALLEGEDLY BATTERED HIM. WHEN ASKED ABOUT HIS ALLEGATION OF RACIAL DISCRIMINATION, THE RS STATED THAT AFTER HIS ARREST AND WHILE HE WAS IN THE HOSPITAL, THE ACCUSED ASKED HIM QUESTIONS ABOUT HIS IDENTITY AND WHERE HE WAS BORN. THE RS BELIEVES THAT TYPE OF QUESTIONING WAS IMPROPER RACIAL DISCRIMINATION. THE RS STATED HE WAS INVOLVED IN AN ALTERCATION INSIDE THE BAR AND WAS ASKED TO LEAVE. WHEN ASKED ABOUT WHETHER HE EXPOSED HIMSELF TO THE WITNESSES- THE RS HESITATED AND CLAIMED HE WAS DRINKING HEAVILY AND COULD NOT REMEMBER. WHEN ASKED WHAT PROFANITIES THE OFFICER SAID TO HIM AT THE STATION THE RS STATED THE OFFICER READ TO HIM THE SENTENCE IN THE POLICE REPORT WHERE THE WITNESSES STATED THE RS TOLD THEM TO "SUCK HIS DICK". BASED ON THE ABOVE INTERVIEW, THE RS'S REMAINING VIABLE ALLEGATIONS ARE REFUSAL TO ALLOW HIM TO FILE A REPORT, FAILURE TO INVESTIGATE, AND FAILURE TO INTERVIEW THE RS BEFORE ARRESTING HIM. THE RS'S CLAIM HE WAS NOT READ HIS MIRANDA RIGHTS IS NOT VIABLE IN THAT HE ADMITS THE POLICE DID NOT QUESTION HIM ABOUT THE INCIDENT.
