



## Administrative Summary Report

### INCIDENT DESCRIPTION

This is a complaint relative to the lack of investigation into a fatality [REDACTED] [REDACTED]. On 12/16/2017, [REDACTED], age 28, fell to her death from the balcony of an apartment where she had been visiting her boyfriend, [REDACTED]. This investigation is incomplete based on text messages and phone calls received from [REDACTED] prior to her death, as well as text messages that were recovered that clearly demonstrated that [REDACTED] was insane and a self confessed liar. [REDACTED] was also immediately represented by his father, an attorney, who flew from Boston to Chicago and was present when he was interviewed. There was no release of information relative to this incident to the media, no news reports, she was transported by private ambulance to the morgue. The medical examiner refused an autopsy and refused a toxicology exam.

During the day preceding her death, [REDACTED] and her boyfriend were acting strangely. They were either fighting or she had some issues. Not being able to contact her during that day, I called the Chicago PD and they made a wellness check to [REDACTED] home. There was no one there.

[REDACTED] when learning that the police had been to his apartment called me and left me several text messages demanding that I call off the police, that everything was alright. I have copies of the text messages. [REDACTED] also advised the police that [REDACTED] was seeing a psychiatrist. That was true as she had ADHD. She had no history of suicide attempts or threats.

Detective Lewis refused to allow her personal property to be removed from the apartment stating that Illinois was a community property state even though she was not residing at that address.

When her computer and recorder were finally received the all the recordings had been deleted and her computer had evidence that it had been tampered with. The balcony was also not dusted for fingerprints to prove that [REDACTED] did not throw off the balcony.

We recovered text messages from [REDACTED] to [REDACTED] that stated

1. That he routinely spoke to the dead.
2. That he was under the care of a psychiatrist and was hooked on multiple prescription meds.
3. That he knew how to be an effective liar and played people.
4. That he had violent sex with prior girlfriends including choking them.
5. That he believed that sex was violence.
6. That he made threats of violence to his prior boss in the text messages.
7. That he spoke of out of his mind periodic outbursts.

Text message excerpt

The girl I dated two girlfriends ago was a little nuts too. She had a serious rape fantasy. Like she wanted to fight back, say no, but be overcome. She fought back hard too. It wasn't playing for her, she actually wanted to hit and taken down. She really liked getting slapped in the face and choked before and during.

Wanted to be hit and with toys and restraints.

I dated two girls before you who were really into 50 shades type of stuff. It's not that it's anything we don't do really, just more formalized roleplaying with toys and restraints.

The girl I dated two girlfriends ago was a little nuts too. She had a serious rape fantasy. Like she wanted to fight back, say no, but be overcome. She fought back hard too. Based on this information our attorney [REDACTED] requested that additional investigation be conducted. Detective Lewis refused.

It would appear that this case was closed out with pressure from [REDACTED] father an attorney, where it deserved a second look.. All we asked was that [REDACTED] be questioned a second time relative to his text messages and lies to the police department. Criminal charges that could apply reckless endangerment, culpable negligence.
