



## Administrative Summary Report

### INCIDENT DESCRIPTION

I was leaving my mothers home who resides in Chicago in the intersection of leavitt and cullerton at approximately 805pm. I was accompanied by my daughter and we noticed a high presence of police. We got into our vehicle and proceeded to drive south on leavitt there was a police car in front of us as we approached the stop sign on the corner of leavitt and 21st street. That vehicle continued to head north and we remained at the the stop. At that point an unmarked police vehicle approached the same intersection on the south west corner of 21st street and leavitt, I proceeded driving south bound on leavitt and was stopped by the unmarked police vehicle between 22nd place and 23rd street and leavitt. A male officer and his female counterpart exited the vehicle . The male officer approached to the driver side and the female officer approached the passenger side. As I began to lower my window my driver side window also began descend. At which point I rolled the window back up. As the male officer approached my window and i lowered my window i asked the officer why i was being stopped. The officer proceeded to say that he stopped me because I ran a stop 3 blocks away and he stated that it was recorded. I proceeded to tell the officer that was incorrect and that I made a complete stop. He then asked me where I was going, I chose not to answer that question so he reiterated the question so I responded by advising the officer that I did not have to answer that question. The female officer asked why I was being hostile in which I replied I was not. He then asked for my Drivers license and insurance card, I provided my ID while I searched for my drivers license and attempted to retrieve my insurance via my mobile app. As the officers retreated, the female officer approached my drivers window and I provided her with my insurance card. She then proceeded to tell me that she was not giving me a ticket for not stopping at the stop sign instead she was giving me a ticket because my passenger picked up the window. I asked the officer if her camera was on she said yes, I then asked her to repeat what she stated and I turned on my cellular camera when she then stated that she was giving me a ticket because I didnt stop at the stop sign. I reiterated to her that she just told me she was issuing a ticket due to my passenger rolling up the window. She asked for me to sign the ticket which I refused and issued me the ticket and kept my license. I believe that I was targeted due to the vehicle I was driving and in the area I was driving it in. I believe that my stop was unwarranted and without cause because I did make a complete stop at the 2 stops prior and the approaching red light before the unmarked police car activated his siren. The stop was not justified and because I questioned the officers decision to issue me a ticket based on her presumption that my passenger who is my daughter rolled the window up. Her actions were unjustified. Because she allowed her emotions to interfere with her judgment she presumed my daughters action were a direct attack on her person. Which is false, my daughter did not with mal intentions roll the vehicle window up. My vehicles windows both driver side and passenger side were unintentionally rolled down upon the initial contact with the officers. This happens because my vehicles window with a touch of a button scroll down, as I made contact with the same button the windows automatically roll up and the female officer took this action personally and based her decisions on an insignificant action that had no merit on the original cause for the supposed infarction. However, had the officers not stereotyped me because of the vehicle I drive and the location I was in i would have not been stopped. I am a law abiding citizen and have the upmost respect for Chicago police officers especially for all the negative attention they receive. This was very disappointing, my mother is disabled and I was delivering her groceries and had her dinner delivered. These officers actions have hindered my desire to return to that area due to how citizens are treated. Im hoping this was an isolated event.
