Allegation: It is alleged that by the complainant Sgt. [REDACTED] that on 28 June 2019, while at the location of 35 [REDACTED] S. Michigan Avenue, the accused Assistant Director KHAN, stated that he has friends in the Mayor's office causing [REDACTED] to be concerned with retaliatory action if she didn't report to Unit 138.

Michigan Avenue, the accused Assistant Director KHAN, improperly utilized the Performance Recognition System by adding unfavorable comments in an attempt to ruin her future with the Department.
