on August 2nd around 1120am i was physically assaulted inside the OGILVIE train station near CVS. The man was black, maybe mid thirties, wearing a blue collared shirt, black shorts, a cap and a bookbag. I have never seen this man before. He pushed me down to the ground and smacked me. I ran inside CVS shook up, the manager walked me to where 3 officers were sitting. Their badge numbers are 16269, 4189 and 11906. The cvs manager explained that i was just assaulted and the person who assaulted me was still standing inside. The officers said Call 911, i was in tears and my clothes were hanging off. I could not believe what I heard, the man who assaulted me was still inside and these officers decided to not protect me. The man continued to pace around and i feel like he was waiting on me. I went back and told the officers that they were sending a cop car, but could they at least hold the man til the new officers came, they obliged. This is unacceptable, i could have been killed The officers sandwich was more important than my safety.
