### INCIDENT DESCRIPTION

Two law enforcement officers may have been involved, but this report is in regards to the uniformed Chicago Police officer Jack Pasquale who responded at the end of a road rage incident with the driver of a Hummer hereafter referred to as Hummer Guy that had indications it was driven by an officer or family member of one.

The uniformed officer refused to make a report of any kind so that the psychotic behavior of Hummer Guy could be documented. I did videotape the second half of Hummer Guy following me and me stopping and waiting for the police but I stopped recording when they got there. He then just tried to shoo me away before I could get any information on the man who had threatened me in an extended incident.

Incident occurred yesterday, 8/20/19, between 930 and 10am. The actual problem for which I needed an officer began in Bensenville, with a Hummer Guy getting enraged when I stopped for a slow count of 2 Mississippi at a stop sign when he was driving rudely close to begin with. I made a police report about it in Bensenville this morning BEP19010392, taken by Officer J Melone. That incident ended after Hummer Guy followed me in a dangerous and erratic manner for more than 4 miles no matter what I did, and I dangerously stopped traffic at a purposefully chosen spot at the intersection of Irving and Mannheim because I figured wrongly that risk of death from the semi's barely missing us would make Hummer Guy pass me and I could get away. An airport worker saw and stopped, I asked him to call the police and he did and waited for them to arrive.

Here's my complaint Uniformed officer arrives, quick interchange between Hummer Guy and cop before he came to my window. I drop the weapon I had in my hand just in case, stop filming and tell him what happened and that I got half of it recorded. He asks if there is any physical damage, which is a strange question when I never said there was contact. He said I should just go. I thanked him for getting my side and letting me get to my dog walks for which I was now late, got a picture of him for his info, and asked how I could get a copy of the report after it was made should I so choose. He informed me he had no intention of making a report as no crime was committed, without asking to see any of the recording of the incident or any further questions. I pressed him and made him reassert again that he would not make a report. I then informed him I needed to get the rear plate of the Hummer and to keep that guy in his vehicle while I did. I could not figure out why that caused a frightened look on the face of Officer Pasquale, but just reasserted that I simply was not comfortable with no documentation of this craziness, especially since Hummer Guy had gotten out and very loudly made sure he had my license plate number for whatever use he would need MY info for.

Hummer Guy may also have been making a phone call to an officer he knew would be friendly when he was loudly reciting my license plate number. I may never know since I was not allowed to have a report made yesterday to preserve accurate record of what happened so I am left to assume. I literally don't know what else Hummer Guy would need MY plate number for, unless he was planning future harassment after getting away with this not being documented. Which Officer Pasquale tried to ensure happened.
