INCIDENT DESCRIPTION

At about 9:30pm on 3/2, I saw CPD vehicle #7378 driving very, very slowly in the bike lane heading east on Farwell between Greenview and Glenwood with every bright light on. It was obvious that the vehicle speed, nearness to the north sidewalk, and the bright lights were aimed at a group of black teenagers. I watched this officer follow for about 5 minutes in this same manner. When I asked the officer why he was doing this, he said he didn't need to tell me. He also refused to provide me with his contact info. When I pointed out that he violated multiple traffic laws in his effort to track the children, he told me I should call 911 to report it. I questioned him on calling 911 for traffic violations, but he confirmed that I should always call 911 anytime I witness a traffic violation. I then stepped away from his vehicle and was talking to the kids he was harassing and several other neighbors, including my wife who saw the officer's lights and had joined me. The officer remained nearby in his vehicle with all of his bright lights on, blocking traffic, but not doing anything else. After about 20 minutes of this, I took his advice to call 911 to report his behavior. Almost immediately, he backed up around a corner, ignored 2 stop signs, made a u-turn to park under the Farwell Red Line overpass, facing the wrong way on a one way street. He sat there for another 5-10 minutes until a few adult neighbors walked the children to their house. We had to insist the children go home for their own safety, as we did not know how far the officer's harassment would go.
