I had called the police on June 29th because I was being harassed by another tenant in my building from 7 in the morning until noon he was harassing me the first time I called the police was about 8:00 they came I asked to do a police report and I wanted him arrested because he was threatening me and he was trying to get physical with me I hitting you with the medal of his wheelchair he was swinging it around the cop said we don't have to make a report we have body cameras sounds like okay couple hours later I had to call them again because I was in the day room and the other kind of came in there purposely ran over my foot my bad foot with his wheelchair and then proceeded to swing at me with the metal bar from the wheelchair in self-defense I'm maced the gentlemen that physically permitting I again called the police and the police arrested me they wouldn't talk to any Witnesses and they wouldn't look at the video the video clearly shows exactly what happened I asked if the other guy be arrested cuz I was the one that called and they did not arrest him they said they would after he was seen by the ambulance however they never did so I went up to the police station and the sergeant said he doesn't know why the guy wasn't arrested and to tell the judge at my next court date that you want him arrested made no sense to me this is not the first time that the police have come here when I called them and they refuse to make a report I was harassed I was physically injured and they put me in handcuffs when I was the one that called this makes no sense is sense is it because I'm Asian it's because I'm in a c h a building I don't get it there's numerous times that I can get the dates for and the police that came out that they did not and refuse to write a police report and I verbally asked for 1 you can check their cameras for that I still being harassed by this guy had court today and it's going for trial however if the police would have just done their job from the get-go I would be going through all this do I need to go to Channel 2 News arcan someone do something about this why are the police not doing their job why can I not get a police report why is it next to impossible for me to get written down what happened I'm the one calling and they refuse to do a police report they don't give me body cam video so how is that a police report
