The Reporting Party stated she is a guard with United Security, and she was working at Navy Pier on a 4-hour boat cruise on the Mystic Blue Cruise Boat. The RP alleges one of the guests touched her on her behind in an inappropriate manner without her permission. The RP related she requested the boat captain call the police. And alleges the responding 4 POs stopped and questioned the offender and let him go without arresting or charging him. The RP alleges she requested a police report and the responding officer told her it was not a life threatening situation. The RP described the PO as male white, 6-3, late 40s. The RP went to the 1 District Station and was told to go to the 18th District. The RP went to the 18th District Station and alleges she was told by the desk officer there was no call for service at Navy Pier.
