INCIDENT DESCRIPTION

The complainant stated he was was driving his disabled aunt home and parked in a loading zone in front of her home to assist her in getting inside. The complainant left the car, which is registered to his mother, parked in the loading zone with the emergency/hazardous lights flashing. When the complainant returned to the vehicle, he had a parking citation on his windshield for double parking/standing. The complainant drove away and the accused stopped him because the accused said he wanted to check who the vehicle was registered to and ensure the complainant was the person cited on the ticket and not the registered owner who in this case is the complainant's mother. The complainant was upset that the accused took extra measures to harass him about a petty citation. The complainant did not have his license with him on his person and the accused him a second citation for failure to produce a driver's license. The complainant stated that as he drove away the accused stopped him again because he had forgotten to check if the complainant had valid insurance for the vehicle. The complainant is upset that the accused further inconvenienced him and believes that the accused was harassing because he questioned the actions of the accused. See attached citations.
