



## Administrative Summary Report

### INCIDENT DESCRIPTION

The accused arrived at the residence of [REDACTED] and her daughter [REDACTED] after [REDACTED] was involved in a physical altercation with an unnamed female individual. In a separate incident that occurred around the same time and at the same location, [REDACTED] was struck by an unnamed male individual. [REDACTED] and [REDACTED] spoke with the accused for about five minutes, detailing their version of events. The accused then interviewed the unnamed female individual for about 45 minutes. After conducting their interview with the unnamed female individual, the accused arrested [REDACTED] for assault. Additionally, [REDACTED] asked to sign a complaint against the unnamed male individual who struck her, but the accused would not allow her to sign a complaint; instead, the accused merged [REDACTED] complaint with the signed complaint against her daughter. [REDACTED] believes the complaints should be separate. Additionally, [REDACTED] believes the written report is inaccurate given that it suggests that [REDACTED] used a knife during the altercation when it was the unnamed female individual who had the knife. [REDACTED] stated three separate times that her daughter's arrest is not her complaint. RD# JC452662.
