Allegation: It is alleged by the Reporting Party [REDACTED] on 01 Oct 2019 at approximately 1217 hours, she was harassed by the accused in that she received a telephone call from the accused who was calling from the 003rd District Police Station Commanders office stating there was a complaint against her regarding a bill at D & D Place Donuts Shop located at 83 [REDACTED] S. Kedzie.

Rule Violation: 2 - ACTION/CONDUCT IMPEDES DEPT POLICY OR BRINGS DISCREDIT - In that it has been determined that on 01 Oct 2019 at approximately 1217 hours, the accused telephoned the Reporting Party from the 003rd District Police Station Commanders office stating there was a complaint against her regarding a bill at D&D Place Donuts Shop located at 83 [REDACTED] S. Kedzie which had no police purpose. [1 count(s)]

Rule Violation: 4 - CONDUCT/ACTION TO USE OFFICIAL POS. FOR PERS. GAIN/INFLUENCE - In that it has been determined that on 01 Oct 2019 at approximately 1217 hours, the accused telephoned the Reporting Party from the 003rd District Police Station Commanders office stating there was a complaint against her regarding a bill at D&D Place Donuts Shop located at 83 [REDACTED] S.
