During the investigative process they interviewed me by phone and later told her she could not enter the police academy if she did not end our relationship. She did not end it, and I did not move out but she told them she ended it. Once she got into the academy, it was me who drove her to the academy everyday, the cameras will show. I also ironed her uniforms and met coworkers as well. She would ask me to hide when the investigator would come to our house.

My i.d. today still has her address on it. Upon receiving her star, we still continues a relationship. I have bank records, pictures, texts, emails, witnesses to prove my claim. While in the academy she started an affair with a fellow classmate behind my back, whom she still sees today. She is a complete fraud. She got the job under false claims and continued to entertain a convicted felon against company policy. She continuously plays with the court system and abusing her badge by calling the police on me with lies. She called them multiple times last year, and then she didn't follow up with the order of protection and even asked a detective not to arrest me. (I have the voice mail from the detective stating this) Her latest antic is lying again to get an order of protection against me after I broke up with her for the final time 3 months ago. Please contact me as I intend to go the the news and internet media with my truth. She has abused me then uses the badge and the fact that I'm a convicted felon to dupe people that she's an angel when she is not. Thank you for your time.
