The Reporting Party stated as she was walking to the Metra station she flagged down a police vehicle because she saw a big dog walking alone unleashed. The RP alleged she asked the officers to escort her to the station and they told her they could not. The RP stated the officers followed her in the vehicle until she reached the station safely but she felt they should have escorted her in the police vehicle. The RP describe the officers as male black in department issued uniform.
