INCIDENT DESCRIPTION

The Reporting Party stated she is the Dean and P.E. teacher at Myles Davis Magnet School. The RP reported during PE class one of the 6th grade students forcefully pushed her to the ground causing injury to the left side of her body. The RP alleges the accused Officer Flakes was nearby and did not intervene prior to her being injured. The RP further alleges the accused officers Nosek and Booker failed to arrest the student for battery.
