INCIDENT DESCRIPTION

On November 17, 2018 two Chicago police officers reported coming to the scene of an accident to report a crash involving a motorist and a bicyclist. The officers Edward Day star number 9106 and Officer J. Menoni star number 995 never showed up on the scene. Both officers filed a false fabricated police report alleging the motorist was a fault. Nonetheless. on November 17, 2018 went to the District 10 location to make an incident report # JA515828 with the deputy clerk Officer Layne of the Chicago police department located at 14 S. Blue Island in Chicago on November 17, 2018 around or about 6:30 p.m. Municipalities have a duty to serve and protect all of its community members. The Chicago police failure to maintain transparency in compliance with the Chicago police departments penal code in reporting traffic crash reports is a violation of ILCS 720/5 of the Illinois statute of false reports. As a result of the fabricated report made by the two police officers, they inadvertently recruited individuals who were told to harass and stalk on a continued basis. The recruits are male men who have be harassing as a result of the false report. (men and women riding Bicycles and Males showing up in places of excess) The conspiracy involves the two Chicago police officers Day and Menoni and a legion of other individuals in the city of Chicago and suburbs who have been tracking the whereabouts of The individuals are told to harass and gain close proximity to as possible to elude a false association of a male image. It has been discovered as a secret plan by a group of people twit the Chicago police has induced these individuals to do something unlawful and The act has caused extreme emotional distress and it is very offensive.
