INCIDENT DESCRIPTION

██████████ and his family were threatened by an unknown individual who brandished a firearm. A complaint was filed at the 16th District and the accused was assigned to the case. ██████████ reports that during a phone interview with the accused, he seemed dismissive and uninterested in the incident. ██████████ attempted to contact the accused, but for three weeks was told that the accused was on vacation. After waiting several weeks, ██████████ met with the accused who stated he would contact the suspect and afterwards he would contact ██████████. He was also dismissive during this meeting, making statements like "this is a minor misdemeanor and the suspect would only receive 2 hours of community service" and "I don't have time to deal with cases like this." About a week later ██████████ contacted the accused for a status update, the accused blew ██████████ off by saying he has not contacted nor does he plan to contact the suspect and the case is now suspended and it could be suspended forever. ██████████ has not heard from the accused or anyone else from CPD since.
