Comp entered the 003rd District station on 19 Nov 19 at approximately 0910 hours, and requested to speak with a Supervisor. Comp related to R/Sgt. that the accused officer continues to harass him regarding the complainant parking in the wheelchair accessible spaces at the gas station. The gas station is located at 71st/Indiana. The comp informed the R/Sgt. that he currently possesses a placard for parking, which the accused observed. Comp stated this harassment has occurred on 3 separate occasions from 23 thru 25 September. Comp stated the accused issued him the attached citation (for complainant's girlfriend vehicle). Complainant also provided R/Sgt. with the photo of the accused officer, and the original Sergeant to whom he reported these incidents.
