THE REPORTING PARTY STATES THE POLICE RESPONDED TO A NOISE COMPLAINT INVOLVING THE REPORTING PARTY'S NEIGHBOR, A CHICAGO POLICE OFFICER. THE NEIGHBOR WAS DIRECTED TO KEEP THE NOISE DOWN. THE ACCUSED OFFICER, THE NEIGHBOR, SENT THE REPORTING PARTY THREATENING TEXT MESSAGES SAYING WORDS TO THE EFFECT OF, "YOU KNOW I AM THE POLICE. DON'T TRY TO EMBARRASS ME BY CALLING THE POLICE,. I WORK IN THIS DISTRICT. YOU KNOW I CAN CITE YOU FOR ANYTHING IF I WANT TO. "

Allegations

1 - Sustained - Operation/Personnel Violations

Allegation: It is alleged by [REDACTED] (Reporting Party 1) and [REDACTED] (Reporting Party 2) that on 24 November 2019 at approximately 0140 hrs. the reporting parties called the Chicago Police to report a noise complaint in that their neighbor who live above them in a rear coach house was playing loud music. The reporting parties know their neighbor playing the loud music to be Samuel Robinson a Chicago Police Officer that works in the 012th District. After the police arrived at 0240 hrs. it is alleged Samuel Robinson sent several messages to the reporting parties that stated: Message 1 "Dude you realize I am police, I work in this District, next time you think police can or will do something I'll call on you for every noise every smell of food you make etc. Don't try to embarrass me for some petty bullshit that's a civil manner. I'll be messaging John on the matter to further update because he is well aware." Message 2 "I told you before I rent here and well long before you, I love here alone and not with 3 others in a one bedroom apartment, you want peace and quiet AGAIN. Go buy a home." Message 3 "I don't want to have to remind you again, because I can legally and will cite you and everyone you are staying with every violation I see and experience occur. This will be the last text you receive from me I hope you take heed."
