#### INCIDENT DESCRIPTION

Reporting party was dropped off by her grandmother at the dental office for a surgery on her wisdom tooth. She was seated in the waiting room when the dental assistant called her up to verify she was there for an appointment. Standing beside her, he said, "What up, China?" He then physically touched her and rubbed her shoulders. He walked her back into an exam room, sat her down in the examination chair, then went and got her file and x-rays. He began to explain the procedure to her, showing her an x-ray. He then rubbed her shoulder again and rubbed her breast twice. He then reclined her chair and rubbed her inner thigh. He left and then returned. He rubbed her thigh and then reached toward her vagina. He proceeded to continue explaining things to her and then grabbed her hand. Reporting party then went into the restroom and called her grandmother. Her grandmother then came back to the office and together they called the police. She pointed the dental assistant out to her grandmother and her grandmother told him he should only be touching her mouth. Together they then called the police. The police came and gave her a police report, but did not arrest the dental assistant. Reporting party alleges the police report is insufficient, the person who assaulted her should have been arrested and her case was never properly investigated or assigned to a detective.
