INCIDENT DESCRIPTION

Reporting Sergeant spoke to complainant over the phone @ 2045 hrs 21 Dec 19 immediately after receiving a message from OCC to call complainant. Complainant alleges that on 21 Dec 2019 @ 2000 hrs he was driving his vehicle northbound on Mannheim road after exiting off of 190 expressway. Complainant related he was lost and cut over a few lanes of traffic to his left in order to make a left hand turn onto Zemke road. As complainant was making the left hand turn he notices a vehicle immediately behind him blowing its car horn. Complainant then heads west on Zemke road and then curves southbound onto Bessie Coleman drive when complainant observes the vehicle blowing the horn to be a marked Chicago Police squad car. Chicago Police squad car then executes emergency lights and pulls alongside complainant's car. Complainant relates that a male sounding subject inside the squad car then yelled towards him "you could have caused an accident motherfucking asshole cocksucker". Squad car then drives away. Complainant reported that the marked squad car had vehicle number 2508 on the body of the car and that he could not provide a physical description of the person in the vehicle or how many persons were in the vehicle because it was dark. Reporting Sergeant initiated a complaint after hanging up the phone with complainant. Reporting sergeant started this complaint under another number 2019-055187 but utilized the save button half way through report and was not able to log back in to continue because of system message (you do not have permission to this record ARNOTE 40202).
