The reporting party alleges the accused officers responded to the reporting party's residence after an individual was trespassing and attempted to force his way into the reporting party's condo building. The officers refused to take any action against the trespasser, and a Sergeant was called to the scene. The reporting party obtained a police report which incorrectly indicates the reporting party was involved in mutual combat with this trespasser.
