1 - Sustained- Operation/Personnel Violations / Conduct Unbecoming

Allegation: The complainant, [REDACTED] alleged that on 06 Jan 2020 @ 0240hrs at 66 [REDACTED] S. Greenwood Ave Chicago Il, the accused, Chicago Police Officer Eric Reyes #19120 said "I don't fucking know, ask them upstairs" when asked why police were at his residence.

Rule violation: 2 - ACTION/CONDUCT IMPEDES DEPT POLICY OR BRINGS DISCREDIT – BWC shows accused state "ok, go upstairs and tell them" "what the fuck are you standing in front of me for" "I don't want to talk to you". (1 count)

Rule violation: 6 - DISOBEDIENCE OF AN ORDER/DIRECTIVE, WHETHER WRITTEN OR ORAL – Disobedience of Rule 2 and 8. (1 count)

Rule violation: 8 - DISRESPECT/MALTREATMENT OF ANY PERSON WHILE ON OR OFF DUTY – BWC shows accused state "what the fuck are you standing in front of me for" (1 count)

Allegation: The complainant, [REDACTED] alleged that on 06 Jan 2020 @ 0240hrs at 66 [REDACTED] S. Greenwood Ave Chicago Il, the accused, Chicago Police Officer Eric Reyes #19120 said "Dude, you got knee pads on, those are suppose to be for your girl."

Rule violation: 8 - DISRESPECT/MALTREATMENT OF ANY PERSON WHILE ON OR OFF DUTY – BWC shows accused state "your kneepads" "because you got knee pads on"" back the hell up then". (1 count)
