3 - Not Sustained - Conduct Unbecoming Violations

Allegation: The RPV [REDACTED] alleges that on an unknown date @ an unknown time and at an unknown location the Accused E.T. WAFER #12366 falsely filed a police report alleging that the RPV stole belongings from the home his mother left him recorded under RD #HZ- 435600.

4 - Not Sustained - Conduct Unbecoming Violations

Allegation: The RPV [REDACTED] alleges that on the date of 09 May 2018 @ 1400hrs, at the location of the 022nd District the Accused E.T. WAFER #12366 falsely filed a police report alleging that the RPV forged a signature to his mother's will recorded under RD #JB-256583.

5 - Not Sustained - Conduct Unbecoming Violations

Allegation: The RPV [REDACTED] alleges that on an unknown date and @ an unknown time, and at an unknown location the Accused E.T. WAFER #12366 falsely complained to CPD- Internal Affairs alleging that the RPV harassed her based on opening the RPV's mail recorded under LOG No: 2019 - 0002954.

6 - Not Sustained - Conduct Unbecoming Violations

Allegation: The RPV [REDACTED] alleges that on an unknown date and @ an unknown time, and at an unknown location the Accused E.T. WAFER #12366 attempted to use the police powers of her office to harass the RPV by intimidation.

7 - Not Sustained - Conduct Unbecoming Violations

Allegation: The RPV [REDACTED] alleges that on the date of 12 Oct 2017 @ an unknown time, at the location of the 5 [REDACTED] W. Harrison St. (Domestic Violence Court) in Chicago the Accused E.T. WAFER #12366 lied several times violating Rule 14 of the Rules and Regulations of the Chicago Police Department in a Cook County Court room with regard to Chicago Police Department police reports.

8 - Not Sustained - Conduct Unbecoming Violations

Allegation: The RPV [REDACTED] alleges that on an unknown date and @ an unknown time, at the location of 22 [REDACTED] W. 119th St. in Chicago the Accused E.T. WAFER #12366 committed a crime when she admitted to opening RPV's mail, as recorded in court transcript #17-OP-72084 and also recorded under Allegation #3 of LOG No. 2019 - 0002954.

Allegation: The RPV [REDACTED] alleges that on an unknown date and @ an unknown time, and at an unknown location the Accused E.T. WAFER #12366 made threatening statements in the effect to the RPV's family members and friends that the Accused's goal was to bring the RPV down by any means.

10 - No Affidavit - Conduct Unbecoming Violations

Allegation: The RPV [REDACTED] alleges that on an unknown date and @ an unknown time, and at an unknown location, the goal of the Accused E.T. WAFER #12366 was to defame the character of the RPV.
