INCIDENT DESCRIPTION

Civilian Complaint: Complainant's car was punched by an unknown individual. The individual walked away and waited on the bus stop, so the complainant went inside the police station to talk to an officer. The complainant explained that the individual was standing at the bus stop in front of the police station. The accused officer did not provide service and let the individual get on the bus. Complainant further alleges the accused officers mocked and laughed at him by joking that they could have arrested the individual who punched complainant's car.

1 - Not Sustained - Operation/Personnel Violations/Slow/ No Response

Allegation: The complainant, [REDACTED] alleged that on 19 February 2020 at 1815 hours at the location of the 016th District-Jefferson Park Police Station located at 51 [REDACTED] N. Milwaukee Ave. Chicago, IL 60630, P.O. Dave HOWSKI #5714 had a slow response when the complainant, [REDACTED] asked P.O. Dave HOWSKI #5714 to arrest an offender who just caused damage to the complainant's vehicle who was sitting on the northbound Milwaukee Ave. CTA bus.

2 - Not Sustained - Operation/Personnel Violations/Inadequate/Failure to Provide Service

Allegation: The complainant, [REDACTED] alleged that on 19 February 2020 at 1815 hours at the location of the 016th District-Jefferson Park Police Station located at 51 [REDACTED] N. Milwaukee Ave. Chicago, IL 60630, P.O. Dave HOWSKI #5714 failed to take police action by not arresting an offender who struck the complainant's vehicle two times with his hand at the intersection of Foster Ave. and Milwaukee Ave.

3 - Not Sustained - Operation/Personnel Violations/Conduct Unbecoming

Allegation: The complainant, [REDACTED] alleged that on 19 February 2020 at 1815 hours at the location of the 016th District-Jefferson Park Police Station located at 51 [REDACTED] N. Milwaukee Ave. Chicago, IL 60630, P.O. Dave HOWSKI #5714 laughed at the complainant after the offender made good his escape on a CTA bus.
