The complainant, who is a detention aide assigned to Central Detention, stated that he worked 3rd Watch on the date of this incident and left the building to go to his car and go home when he received a call from the accused sergeant. The complainant alleged that the accused falsely accused him of having left early and out of policy when he did not. The complainant further alleged that he explained to the accused that he did not leave early and he was properly relieved of his duties for the shift when the accused stated to him, "Bullshit, you're completely full of fucking shit" and hung up the phone.
