Immediately officer finingan, female was aware of the situation we have been having with this neighbor shooting at our house all hours of the day and night. I even presented the 3 ops that we have been trying to get since the first business day of the new year. She was so disrespectful to me from the moment she opened her mouth. Loudly in the gangway where all the damage is occurring from this criminal, she said I don't see any damage, without looking. She told me I should move. She also questioned my sanity, as if I was crazy or some kind of liar. She told me I should get help because I seemed "agitated". Well of course I'm angry and rightfully so. If her home was being shot at and had extensive damage, she would be angry too. Mind you the man shooting at my house heard her insult me and my integrity. As if seeking help from the police is not my right as a citizen of Chicago. I am tired of being treated like this from the very ones who pledge to serve and protect law abiding citizens. What am I to do when my home and wellbeing are under attack. We are trying to do everything by the law to bring justice to a very unjust situation. She also told me while she was leaving that I should hire security. I thought the police were the ones who are paid by tax payers to serve and protect us, not criminals. So after two years of calling 911, going to 5███ W. Harrison and Grand and Central for an arrest warrant. I am verbally abused by this officer. Can't logically think of why the police are protecting this criminal, who likely is the one with the "mental" issues. And she's not the only uncouth and unprofessional officer I have I encountered from the 16th district.
