INCIDENT DESCRIPTION

It is alleged that on 10 March 2020, at approximately 1349 hours, the Accused member, Detective Terance NALLS placed an unsolicited telephone call to [REDACTED] inquiring about Log Number [REDACTED]. NALLS asked [REDACTED] "Do you have something you want to talk to me about?" [REDACTED] joined the conversation, at which time NALLS admitted to interfering with the Log Investigation as the complainant, [REDACTED], believed that if she dropped her complaint, he would reconcile their relationship. NALLS further stated he was on the line during the conversation between [REDACTED] and [REDACTED] when she expressed to [REDACTED] she no longer wanted to pursue her complaint.
