#### INCIDENT DESCRIPTION

On Sunday June 7, I attended a protest that began at Barnard Park at Longwood & 105th. About 12 officers were lining the park, standing shoulder to shoulder, but none were wearing facemasks. I approached one to ask where his facemask was, Badge # 19974, nametag Connell. He said none of his superiors and nobody else was wearing them, so he wasn't going to. He ignored my concerns for mine and others safety from the pandemic and how cops were putting themselves and protesters at risk. As the protest proceeded, cops continued to stand close to each other and to protesters, with no facemasks. I could not get everyone, but only about 2 out of 50 or so were wearing masks. From the pictures I took at 111th & Western when we were surrounded by cops, I was able to collect the names and #s of other officers breaking the rules as well and putting us at risk of a second wave of COVID-19. In ADDITION, TWO OF THE OFFICERS HAD BLACK TAPE COVERING THEIR BADGES AND NAME TAGS.

Here were folks on the scene who were not wearing masks that I have ID for:

I have a photo of Fred Waller, Chief of Patrol Officers talking to protesters without a mask on. Standing next to him was Commander Joyce of the 22nd district, also with no facemask. I start with these two because of all the cops I've spoken to (since NOBODY is wearing masks or gloves anymore), they all blame their superior officers. Well, here are the superiors clearly disregarding public safety.

Other officers present with no facemasks (keep in mind this is only a tiny fraction of the total present who didn't wear masks, but I couldn't get everyone's info) - I believe most if not all are district 22.

O'Connor, I think his badge is 11380. He was also heckling protesters.

Ponce - his badge number looked like 77493 or maybe 11493, honestly it seemed like he was wearing someone else's badge. He was covering his badge most of the time, and though there is an Antonio Ponce in District 22, that badge # was 15414, which is DEFINITELY not what his badge read, and he looked to be pretty young, but Antonio Ponce is supposed to be 53. So, unclear if folks out here were switching nametags and badges as well.

I have photos of all these officers, as well as the ones who covered their badges.
