Throughout Lieutenant GARRIDO's posting, he implied he was a member of the Police Department, used the acronym "CPD" that stands for Chicago Police Department, and used communication that discredited and reflected poorly on the Department. The Facebook post did not support the Department's vision, mission, values, and goals. While the posting did support the Police Officers, it used negative language during a period of civil unrest that spoke poorly about people involved in the protests and political leaders. Lieutenant GARRIDO aimed his posting at everyone that was not his friend or who did not support the Police, as the first line of his posting stated.

Rule Violation:

6 - DISOBEDIENCE OF AN ORDER/DIRECTIVE, WHETHER WRITTEN OR ORAL - It has been determined that on 05 June 2020 Lieutenant John GARRIDO #633 violated General Order G09-01-06 titled Use of Social Media Outlets when he made a posting to a webpage named Facebook. The posting used inappropriate comments related to the recent protests. After reviewing the Department Order and Lieutenant GARRIDO's Facebook post, it has been determined that Lieutenant GARRIDO used a public social media webpage named Facebook, and represented himself as a Chicago Police Department member. The words Chicago Police Department and an image of a Chicago Police Officer star are present on his profile icon which implied he was a member of the Chicago Police Department. That image from his profile picture and wording from his Facebook post showed that he represented himself as a member of the Department. Throughout Lieutenant GARRIDO's posting, he implied he was a member of the Police Department, used the acronym "CPD" that stands for Chicago Police Department, and used communication that discredited and reflected poorly on the Department. The Facebook post did not support the Department's vision, mission, values, and goals. While the posting did support the Police Officers, it used negative language during a period of civil unrest that spoke poorly about people involved in the protests and political leaders. Lieutenant GARRIDO aimed his posting at everyone that was not his friend or who did not support the Police, as the first line of his posting stated. Lieutenant GARRIDO did not have authorization from the Superintendent or his designee to use the Chicago Police star on his personal Facebook page. [1 count(s)]
