INCIDENT DESCRIPTION

Dear Mr. / Ms.,

My neighbor, officer Spiro Maglaras, told me on two separate days: "if you don't back down there are going to be some serious problems". This happened during the summer of 2013, right after me and my family moved in. I was watering the grass in my front yard while this happened and he came straight to my face (noses touching) to tell me this. The past seven years I can only speculate why this happened, and since I am not fully sure what his reasoning is, I told him to leave me and my family alone. His said he would leave us alone. Though, soon after he threatened our construction workers who were installing a concrete side path, that if they didn't install a water collecting system there were going to be serious problems. Hence, we installed a drain pipe to collect excessive rain water. The reason I am submitting this complaint now, is that Spiro managed to threatened our construction workers again recently (June 24th) when they accidentally left a part of a water hose on his side yard. Spiro yelled at them. Honestly, I am done living in fear not knowing what I have done wrong, and having my contractors receiving threats. Preferably I have things resolved with him, but a cop that tells me I am going to be in some serious problems is in my opinion unapproachable and is not willing to listen. My request is to have someone with authority to let Spiro know he cannot threaten his neighbors like this, and that his behavior is highly inappropriate. I am very saddened things cannot be resolved in a mature matter with somebody from the police force. Me and my family are also very saddened that our children (both Spiro's and ours) have to live through this unnecessary arguing. These incidents might seem minor, though please address this to mr. Maglaras as I do not feel comfortable continuing living next a verbally abuse officer.

Allegations

Allegation: It is alleged by the Reporting Party on unknown date during the summer of 2013, at 60█ N. Tripp, the accused Sergeant threatened the Reporting Party by approaching him and stating, "If you don't back down, there will be some serious problems."

2 - Not Sustained - Conduct Unbecoming Violations/Altercation/Disturbance/Neighbor

Allegation: It is alleged by the Reporting Party on 24 June 20 at 1300 hours at 60█ N. Tripp, the accused Sergeant threatened the Reporting Party after contractors left a water hose on the lawn on the accused. The accused approached the Reporting Party, and stated "If you don't back down, there will be some serious problems."
