### INCIDENT DESCRIPTION

Civilian web complaint: Officers were called to my house because a neighbor threatened to beat my ass. I explained to the officers that a young female had approached me and threatened to beat my ass and that I wanted her arrested and that I would sign complaints against the offender. They asked me if they could just talk to her. I said no. I explained to the officers that I was not going to live like that with people threatening me and destroying my property. Basically the father destroyed my property and I asked him not to do that. The daughter then approached me approximately 15-20 minutes later and stated that she would beat my ass if I talked to her father again. All of this was explained to the officers. The officers did not appear to be interested in doing their job and appeared annoyed that I had asked them to arrest the offender. The officers responded to the home and came out shortly and told me that the offender was not in there. I asked for a police report. To this Officer Dimoff stated "what do you want a report for!" I was stunned. The police are asking me what do I want a report for. I had already told them that i was threatened with bodily harm. I had already told them that I was a retired Police Sergeant from the 22nd District. This showed me that they had no intention on arresting the offender. You go into the house and talk to the offender and you don't know what they did? They told me that they do things differently now. As I was walking away, Officer Stapleton called me [REDACTED] They showed no respect for me at all. He stated that he knew me from the 22nd District, to this I stated, "you know who I am and you treat me like this? I'm not [REDACTED] I'm [REDACTED] or [REDACTED] These officers were horrible and they put me in a worst position than I was in when I called for help. I expected them to handle the situation and help me. Now I am afraid that this offender is going to hurt me. And I have to go through the trouble of getting a summons when they should have handled the situation while they were there. Their attitude, behavior and demeanor were not that becoming of police officers for the City of Chicago. I also informed the officers that my other neighbor was a retired police officer and he may have heard the threat. They did not want to interview him and refused to do so.
