Civilian web complaint: I went to Chicago Police District 7 at 14 W 63rd St. to file a complaints due to a Deceptive Practice I got involved in. I was a victim of Scam worth of \$2000 in Chicago and was reported it. While I was giving my statement to the Lady Sergeant who is assisting me, she was suddenly talk to another Desk Sergeant sharing the incident that I am complaining about. She told to another police about the incident which really makes me uncomfortable. Then, she said, "She is a Prostitute" after looking at me. The man who she talking too, then looked hard at me. I was so embarrassed the way their body language made during the conversation. I couldn't do anything but to cry going back home.

I am seeking help, regarding this matter due to hostile environment I am dealing with until today. The police sergeant didn't indicate her name in my police report which really difficult for me to make a decision of filing this complaints. The case number of the incident was JB-488543. This incident with the police officer had impacted me emotionally and psychologically. I am also experiencing threat from so many people in the neighborhood. My argument is that, How can she speaks a libel statement without evidence. Who is her intelligence? How did she come into that statement accusing me right exactly in the Police Station where I am seeking help. I am a teacher, and because of the rumors and gossiping that people in public continue spreading against me turns into hostile environment as people won't treated me normally. In my apartment, there were several times was broke-in by different men using my personal things, such as soap, razor and other personal things. When I tried to use my razor, there was a strange hair in it. Somebody put empty dirty Styrofoam in my refrigerator. These are just some of the hostility I have experienced. Several people of different men break-in in my apartment. I have to call a police during this incident. The case number was "J478332". some reports were not collected a copy which file in the other police District maybe.
