Civilian Complainant: Complainant alleges that the unknown accused Department member placed two skeletons with strings placed around their necks, on a wall, where clip boards were hung, near the front desk, back wall. Complainant stated that he was inside the 005TH Police District. Complainant stated that he is a Black Man from the South and the skeletons with strings placed around their necks are symbolic to lynching of Blacks in the South. Complainant was very disturbed by what he saw and he reported this incident to Channel 5 News too. Correction: 10th District not the 5th District.

Ogden Ave. (CPD 010th District Desk area) an unknown Accused member previously placed two skeletons with strings placed around their necks, on a wall, where clip boards were hung, near the back wall of the front desk. The Complainant found this to be offensive in that, the Complainant alleges that skeletons with strings placed around their necks are symbolic to the lynching of Blacks in the South. (The Complainant is a male Black from the south)
