INCIDENT DESCRIPTION

Reporting Party [REDACTED] alleged that Accused Officer Robert Carrillo # 11813 sexually harassed her between March 2022 and December 2023. R/P alleged that the Accused gave her unwelcome compliments, took photos of her without her consent, repeatedly asked her out on dates after she declined, followed her, and accessed her license plate information through the Department database without proper justification. R/P also alleges that the Accused made contact via phone calls and text after being told to stop and attempted to give her unwanted gifts. Additionally, the R/P alleged that on 01 Mar 2024, at 42 [REDACTED] N. Harlem Ave, Norridge, IL 60706, Accused Officer Carrillo after being notified of an EEO investigation for Sexual Harassment, willfully made contact with [REDACTED], causing additional distress.

Allegations

1 - Not Sustained - Conduct Unbecoming Violations/Harassment

Allegation: Reporting Party (R/P) [REDACTED] alleges that between March 2022 and December 2023, Accused Officer Robert Carrillo #11813 sexually harassed the R/P by giving her unwanted compliments about her body making her feel uncomfortable.

2 - Not Sustained - Conduct Unbecoming Violations/Harassment

Allegation: Reporting Party (R/P) [REDACTED] alleges that on 09 Jul 2022 at the location of 5400 N Lincoln Avenue at approximately 0439 hours, Accused Officer Robert Carrillo #11813 harassed the R/P by taking photograph without her consent.

3 - Not Sustained - Conduct Unbecoming Violations/Harassment

Allegation: Reporting Party (R/P) [REDACTED] alleges that on an unknown date, time and location, Accused Officer Robert Carrillo #11813 harassed the R/P by persistently asking her out on dates even after she declined.

4 - Not Sustained - Conduct Unbecoming Violations/Harassment

Allegation: Reporting Party (R/P) [REDACTED] alleges that between 11 May 2023 and 09 Aug 2023, Accused Officer Robert Carrillo #11813 harassed the R/P by attempting to give her unwanted gifts.

5 - Not Sustained - Operation/Personnel Violations/EEO Investigations

Allegation: Reporting Party [REDACTED] alleges that between January 2024 to February 2024 at the location of 5400 N Lincoln Ave, Accused Officer Robert Carrillo #11813 followed the R/P to her vehicle in the district parking lot despite being instructed to cease contact.

6 - Unfounded - Operation/Personnel Violations/Misuse of Department Records

Allegation: Reporting Party (R/P) [REDACTED] alleges that on an unknown date and time, Accused Officer Robert Carrillo #11813 violated the Chicago Department Police Department policy by accessing the R/P's license plate information for a non-law enforcement purpose through the department database without proper justification.
